and the loving dedication of family continue today
through the inspired efforts of his wife, Susan.

As Charlie finally surrendered to the cumulative effects of
rheumatoid arthritis, Susan learned first hand about the need
for compassionate, professional end-of-life care. It is with pride and
personal appreciation that she and gallery owner Bev Kesterson,
a former hospice volunteer, partner together with Hospice of Wake County
to present an evening of rare opportunity to our specially invited guests.
